## PERMITTEE AGREEMENT (INITIAL EACH LINE)

- THE PERMITTEE SHALL BE FULLY RESPONSIBLE FOR CONSEQUENCES OF BURNING UNPERMITTED ITEMS;
- THE PERMITTEE SHALL KEEP THE FIRE UNDER PERMITTEE'S CONTROL AT ALL TIMES;
- THE PERMITTEE SHALL KEEP THE FIRE UNDER PERMITTEE'S SUPERVISION AT ALL TIMES UNTIL THE SAME HAS BEEN COMPLETELY EXTINGUISHED;
- THE PERMITTEE SHALL HAVE AT THE PLACE OF THE FIRE A GARDEN HOSE CONNECTED TO A PRESSURIZED WATER SUPPLY, OR SHALL HAVE AT SUCH PLACE OTHER FIRE DEPARTMENT APPROVED FIRE EXTINGUISHING EQUIPMENT, IN EITHER CASE READILY AVAILABLE FOR USE, UNTIL THE FIRE HAS BEEN COMPLETELY EXTINGUISHED;
- THE PERMITTEE, BY SEEKING AND ACCEPTING SUCH PERMIT, AND BY CONDUCTING SUCH OPEN BURNING, BECOMES RESPONSIBLE AND AGREES TO BE RESPONSIBLE TO PAY ALL COSTS OF SUPPRESSION OF A FIRE ESCAPING FROM PERMITTEE'S CONTROL. "COSTS OF SUPPRESSION" MEANS COSTS INCURRED BY THE CITY OF NEW MEADOWS, THE MEADOWS VALLEY RURAL FIRE PROTECTION DISTRICT, SOUTHERN IDAHO TIMBER PROTECTIVE ASSOCIATION, OR BY ANY OTHER AGENCY WHICH RESPONDS TO SUCH A FIRE.
